Dear Parents,

Today, we launch the 2021-2022 SVDP Annual Giving Campaign! The campaign is an important fundraising effort to close the gap between tuition and the actual cost per student. Based on the school's current budget, tuition covers only 89% of a student's education at SVDP. The Annual Giving Campaign offers the opportunity to cover this gap through a tax-deductible contribution and prevents significant tuition increases.

Campaign contributions support innovative, creative, and experiential programs for our students and teachers. Some examples include Shakespearience, visual and performing arts, classroom enhancements, and technology upgrades. We continue to make capital improvements to the learning environment. With that in mind, we will be upgrading the school's wifi infrastructure by purchasing and installing state of the art access points.

The goal of the 2021-2022 Annual Giving Campaign is to raise \$200,000. Last year, 88% of the families of SVDP generously participated in the campaign. We received support from corporations, grandparents, alumni, and other friends of SVDP as well. **All students benefit from the funds raised, so let's achieve 100% participation this year.**
